Consent

Consent means words or overt actions by a person in advance, clearly communicating a freely given present agreement to participate in a particular sexual contact or activity. Words or overt actions clearly communicate consent when a reasonable person in the circumstances would believe those words or actions indicate a willingness to participate in a mutually agreed-upon sexual contact or activity. Although consent does not need to be verbal, verbal communication is the most reliable form of asking for and obtaining consent. It is the responsibility of the person initiating the specific sexual contact or activity to obtain consent for that contact or activity.

Amnesty

To encourage reporting, an individual who reports a violation of this Policy in good faith or who participates in a complaint resolution process under this Policy will not be disciplined by the University for their own personal possession or consumption of alcohol or drugs or other policy violations in connection with the reported incident, except as outlined in the Amnesty section of the Sexual Misconduct Policy.

Retaliation

Retaliation against any participant in the reporting and investigation process is strictly prohibited.

Individuals who violate Bethel's policies and/or code of conduct may be subject to discipline up to and including expulsion or termination of employment.

Even if you don't file a formal Title IX complaint, Bethel can provide supportive measures. Some examples are:

- Academic assistance
- Housing assistance
- Mutual no-contact directives
- Additional campus safety measures
