RESIDENTIAL LIFE

Mission of Residential Life

Residential Life is an important aspect of the Christian academic community that Bethel University seeks to foster. It exists to enhance the learning experience by providing a safe and supportive community that is Christ centered and student focused.

On Campus Living Required

It is for educational and developmental reasons that all unmarried, full-time students under the age of 21 and not living with parents are required to live in the university's residential housing and participate in a meal plan, as are most students who receive scholarship assistance from the university. Students under 21 who have lived on campus for four semesters may apply to move off campus before their fifth semester, provided they are not receiving scholarship assistance.

Roommate Requirements

Housing preference is given to single, traditional undergraduate students. It is university policy that every residential student has at least one roommate. In rare cases, if needed and space allows, a single room may be granted. A requesting student who has a documented medical need for a single room will work with the Director for Disability Services to request this accommodation. If approved for this accommodation, a single room will be designated for the student. In the event that space allows, a student who is granted a single room without an accommodation approval will pay an increased room charge. The number of roommates may vary among the residential facilities. Room charges may vary depending upon the number of persons living in a unit, and from facility to facility.

Roommate Agreement

Roommates are considered to be those living in a common space. This includes a bedroom or any other type of arrangement (suite, apartment, or house).

Each student living in campus housing has the right to:

- Access one's room and its amenities at all times (when university housing is open)
- Sleep and study free from undue disturbances

- Privacy and respect for all in a shared living space
- A clean and safe environment (free from perceived emotional/physical intimidation)
- Have guests in the room within limits
- The ability to address grievances/concerns (with Residential Life staff support)

All residential students will be required to complete a Roommate Agreement at the beginning of the year. This agreement will assist roommates in clarifying shared expectations and responsibilities in order to establish a healthy living environment. Upon completion and review by a Residential Life staff member, the Roommate Agreement will be kept in a mutually accessible location. It may be reviewed and/or modified by a staff member if necessary.

Roommate Mediation Process

If conflict is experienced at any point throughout the year, roommates are expected to talk with each other to try and solve the issue(s) first. If guidance is needed, reach out to your Resident Assistant for guidance or advice. If the roommate conflict continues, let your RA know and the RA will set up a roommate meeting to discuss the issues together. If the roommate conflict persists after the roommate meeting with your RA, notify the Resident Director. The RD will mediate the conflict and determine the best steps moving forward. A requested room change will not be considered before the mediation process occurs. While the Residence Life staff will assist you in solving issues, it is your responsibility to actively participate in the solution.

Changing Rooms

Room changes are typically not allowed or possible during the semester. Upon request to the Resident Director, room changes can be made at semester break when approved. The check-out and check-in procedures shall be followed in the event of a room change.

RESIDENTIAL LIFE GUIDELINES

Air Conditioners

No air conditioners of any kind may be installed in the residential facilities.

Bicycles, Skateboards, Rollerblades

The safe use of bicycles, skateboards, rollerblades, etc. is permitted on the campus. Bikes may not be used or stored within the residential facilities.

Students are responsible for the security of bicycles they bring onto the campus. Bicycles shall be removed from the campus at the end of the school year; those left behind after move-out will be disposed of.

Candles and Incense

The use of candles and incense is prohibited; this includes wickless gel candles and candle warmers. Candles will be confiscated. First time there will be a warning, second time there will be a fine of \$25. Diffusers are permitted.

Check-in and Check-Out

Students shall complete a room condition agreement within one week of moving in. Upon leaving the residential facility, whether it be at the end of the school year, or in the case of a withdrawal or change of rooms during the year, each student must officially check-out with the Resident Assistant or Resident Director. The official check-out involves the removal of all the student's possessions from the facility, a thorough cleaning of the room and its furnishings, return of the student's key to campus safety, and review room with the Resident Assistant or Resident Director. Prior to the room review, students must schedule the check-out with the Resident Assistant or Resident Director. Failure to officially check-out of the residential facility will result in forfeiture of the student's housing deposit. In the event of damages: see also Damage and Accountability.

Cleaning and Health Checks

Students are responsible for maintaining a clean space and are responsible for providing their own cleaning products. Cleaning includes sweeping, removing trash, keeping any appliances clean, properly disposing of expired food products, doing laundry, and cleaning bathroom facilities (if applicable). With advance notice to the students, the Resident Director shall perform room inspections regularly throughout the school year to monitor living conditions within the rooms of the residential facilities. If the condition of a room is found

to be unacceptable in any way, the students may be given 24 hours to correct the deficiencies. If, upon the second check, the deficiencies have not been corrected, the residents of the room shall be fined \$25. This fine shall be assessed against their housing deposit. Upon repeated offenses of the room inspection process, the Resident Director may choose to apply any necessary fines upon the initial check of the room.

Curfew

If a student must be late for curfew, prior arrangement should be made with the Resident Director. Curfew violations shall be handled by the Resident Director and may include disciplinary action appropriate to the level of the violation.

Sunday – Thurs. nights: 12:30am Friday – Saturday nights: 2:00am

Students are expected to be in and remain in the residential facilities from curfew until the following morning.

Damage and Accountability

Students living in the university's residential facilities are required to pay a \$100 housing deposit. Students are responsible for any damage they cause to the residential facilities or to any university property. The costs for repair of any such damage will be deducted from the student's housing deposit. If costs exceed the amount of the housing deposit, the excess will be charged to the student's account. In the case where damage within a room, suite, apartment, or house cannot be attributed to an individual occupant, the costs will be equally split between the residents. In the case where damage to common areas within a residential facility cannot be attributed to an individual student or students, the costs will be equally split between the residents of a hall, floor, or the entire facility, as deemed applicable by the Resident Director. Prior to the beginning of each school year, students who have had charges made to their housing deposit in the previous year shall pay the additional funds necessary to bring their housing deposit back to the full \$100 before they will be permitted to move back into the residential facilities.

Decorating

Students are allowed to decorate their rooms if they choose. Decorations must be congruent with university standards (ex: no advertisements, flags or signs related to prohibited conduct, such as drug use, immodesty, etc.). Decorations

may be hung inside the room and are not allowed on outward facing doors and windows that are visually shared by the campus community and guests. Only fasteners that will not damage or leave residue after removal are permitted. Command hooks and strips are recommended. No items should be hung from exposed pipes or fixtures. Students should consult their Resident Director if unsure of the appropriateness of their decorations and/or fasteners. Because of the potential fire hazard, live Christmas trees, wreaths, etc., are not permitted. Any damage caused by removal of decorations will be the student's responsibility.

Early Arrival/Delayed Move-Out

Students are not permitted to move into the residential facilities prior to the posted dates and times, nor stay beyond the posted move-out dates and times. This applies to the beginning and end of the school year, as well as to breaks when the residential facilities are closed. *See: Holidays/Breaks*. Violations of this policy warrant a fine of \$50 per day.

Electrical Appliances

The use of electrical appliances is limited because of sanitation, safety, and circuit overload considerations. Hot plates, "Foreman" grills, griddles, electric frying pans, crock pots, instant pots, air fryers, toaster ovens, space heaters, halogen lamps, sun lamps or infrared lamps are not permitted in the residential facilities. Microwaves, small refrigerators, coffee makers, hot-air popcorn makers, toasters, blenders, and fans are permitted, provided they are UL listed appliances. All extension cords shall be heavy duty and UL listed. Appliances not directly plugged into a wall receptacle shall be plugged into a UL listed power strip with overload protection. Appliances not listed must be approved by the Resident Director.

Emergency Procedures

Fire drills will be held throughout the school year to ensure that residents will be able to evacuate the facilities quickly and safely if necessary. Fire and tornado procedures are posted in the residential facilities. Students who are present at the time of safety drills must participate. Failure to responsibly participate will result in a \$50 fine and may result in disciplinary action. *See also: Security/Safety.*

Firearms/Weapons/Explosives

The possession of firearms, weapons and explosives on campus is prohibited. Refer to the *Student Handbook* for details. Airsoft guns and paintball guns may not be used on campus or stored in the residential facilities.

Furniture

Each student living in a residential facility is provided with the minimum of a desk, chair, bed, and dresser. This furniture may not be removed from the room, disassembled, or modified in any way by the student. Some of this furniture is designed to be arranged in several configurations and, at the beginning of the school year, the Residence Life staff, or Maintenance staff will configure it as closely as possible to the student's request.

Personal Furniture: Students are welcome to bring additional furniture for their rooms. The removal, storage or disposal of any personal furniture is the responsibility of the student. If personal furniture is left behind, a fine of up to \$100 will be assessed for each item and Bethel will not be responsible for storing these items.

Guests

Students are permitted to have guests of the same gender stay with them in the residential facilities. Guests should be peers of the students (not young children, parent, or other adults). In consideration of roommates and other residents, no overnight guest (including other campus residents) may stay with a student more than three nights per semester. If a guest stays with a student more than three nights in a semester, the student will be fined \$50 for each additional night. All overnight guests must be registered with the Resident Assistant and are required to comply with the Residential Life guidelines. Hosting students are responsible for the behavior of their guests.

Hallways/Stairwells

The hallways and stairwells of the residential facilities provide emergency exits for the residents and must be always kept clear. Students may not place personal possessions or trash in these areas at any time. Leaving items in the hallways and stair wells may result in a fine determined by the RD.

Holidays/Breaks

All residential facilities are closed during semester break and spring break. There will be no access to the residential facilities during these breaks. During all academic breaks, most campus facilities (including food service) are closed, and students are encouraged to spend these breaks away from campus. Those who choose to stay on campus during breaks where the residential facilities remain open must notify the Resident Director that they will be staying in their rooms. All university policies, including Residential Life guidelines, remain in effect during breaks.

ID Cards

Each student is issued a university ID card. This card is required to access most of the residential facilities, as well as other facilities on campus. The card is also required when utilizing the student's meal plan. Students are responsible for always maintaining possession of their ID card. Lost, stolen or damaged ID cards may be replaced in the Student Life Office for a fee of \$10. A card that is defective due to normal wear may be replaced at no charge.

Inspections

Authorized university personnel may enter a student's room for reasons of health, safety, general welfare, or to make necessary repairs to the room or room equipment. The university reserves the right to conduct a search or inspection of persons, residential living areas (including rooms and furniture), vehicles, and belongings (such as computers, clothing, bags, etc.) while on university property or during university sponsored functions. A search or inspection will be approved by a Student Development Director or Vice President for Student Development if there is "reasonable cause to believe" (not the protected criminal law standard of "probable cause") that a search is justified. The university right to search or inspect rooms, vehicles, or belongings, can occur without warning, and with or without the student present. A student who lives in campus housing must submit to a reasonable search by university officials when deemed necessary. Several university officials (including Residential Life, Student Development, and Campus Safety) are charged with the responsibility of maintaining and prompting safety, order, and compliance with university policies. Items, substances, and information discovered during a search may be retained by the university and, when appropriate, may be turned over to law enforcement authorities.

Keys

All students are issued keys to their rooms, apartments, or houses. Students are responsible for always maintaining possession of their keys. In the event of a lost key, the student shall report the loss to the Resident Director and visit Campus Safety to acquire a replacement for a fee of \$25. Failure to return a key upon move-out shall result in a charge of \$25 being assessed to the student's housing deposit.

Laundry

Free laundry facilities are available to all campus residents and may not be used by outside guests. Students should remove their items from the machines in a timely fashion, clean up detergent/softener spills, clean out lint traps with each use, dispose of dryer sheets and follow posted instructions for machine use and detergent/softener use. Bleach may not be used in any washer. The Resident Director may assess a fine for improper use of the laundry facilities.

Lounges/Lobbies

Several of the residential facilities have common areas which are open to members of the opposite sex. Lounge furniture is to remain in these spaces. Removal may result in a \$25 fine. See Lounge Hours. See also Open Dorms for expectations. During breaks, the Bridges and Sailor Lobbies only, will be open from 8:00am – midnight.

Maintenance Requests

Students shall report any problems with the residential facilities to their Resident Assistant or Resident Director. The Resident Director will file a maintenance request to have the problem corrected. Students should notify the Resident Director if the problems are not corrected within a reasonable amount of time.

Media: Music, Movies, Shows and Video Games

Students are generally permitted to use any form of media on campus unless it contains sexually explicit or pornographic material, excessive profanity, or violence, promotes or celebrates the occult, devalues a particular gender or race, or devalues the worth of God. Movies, music, shows and video games with warning labels, ratings for mature audiences, or "R" (restricted) ratings should be avoided unless they are specifically designed for educational and/or cultural purposes.

Students are encouraged to use wise judgement regarding the content and quantity of their media consumption and consider how their media choices may affect others around them. University staff members, including Resident Assistants, are responsible for maintaining a healthy and edifying living environment for all students, and will prohibit any form of media that is considered in poor taste or in conflict with the university's mission and policies. Students who repeatedly violate this policy will be subject to disciplinary action.

Illegal Downloading:

Illegal file sharing and the downloading or possession of copyrighted materials is prohibited.

Public viewing:

It is illegal to show films in public venues unless rights are obtained, and appropriate fees are paid. Because of copyright laws, movies may only be viewed in a student's room.

Pornography:

Pornographic materials in any form are not to be viewed, possessed, or distributed on or away from campus. Further, the use of institutional or personal computers for the viewing, transmission, retrieval and/or storage of such material is prohibited.

Open Dorms

"Open Dorms" is the only time that members of the opposite sex are permitted in the residential facilities, other than in the lounges.

During Open Dorm hours, all residents of the facility must be modestly clothed while in the facility's common areas, or in their rooms if the door is open.

Open Dorms Hours:

Fridays 6:00 pm – midnight Saturdays and Sundays, noon–midnight

When members of the opposite sex are present, room doors must be fully open, and the overhead lights kept on. The window blinds to the common areas in the Perimeter houses must be fully open when members of the opposite sex are present. When visiting an apartment, the opposite sex may visit all areas except the bedroom. If a bed is used as a couch, students must be sitting up, as if in chairs. Inappropriate activities including making out, overlapping, and sharing a blanket are not permitted. Any violation of the "Open Dorm" policy will result in disciplinary action. Repeated violations of the policy may result in the suspension of "Open Dorms" for individuals, select rooms/apartments or the entire residential facility for a period of time, as determined by the Resident Director.

Overnight Absence (Staying Off Campus)

Students must notify their Resident Director or Resident Assistant whenever they choose to spend a night off campus and will provide a contact number where they can be reached. Students are not permitted to stay overnight alone with a member of the opposite sex.

Pets

Pets are not permitted in the residential facilities, except for small fish.

Quiet Hours

These hours are required out of respect for others in the community.

Residential Facility Meetings

There will be a meeting for all the residents of each residential facility

Quiet Hours:

Quiet hours are from 11 pm to 7 am and from midnight until 8 am on Open Dorm nights.

at the beginning of each semester to review residential facility and university policies, announce upcoming events, and answer questions. The Resident

Director may call additional residential facility meetings as necessary during the year. Attendance at these meetings is mandatory unless excused by the Resident Director. Failure to attend will result in a \$25 fine.

Security/Safety

For security and safety, most residential facilities have controlled access entries. Tampering with, disabling, or overriding a security, access or safety system — including individual door/room locks — is prohibited and will result in a fine of \$50 and/or disciplinary action. Students are cautioned not to let strangers into the residential facilities and should call their Resident Director or Campus Safety whenever unsure. The university holds no responsibility for lost, damaged, or stolen items. Students are strongly encouraged to keep their rooms locked at all times when not present.

Students should keep records of the serial numbers of their valuables and never leave cash, purses, or wallets in plain sight. Campus Safety provides an engraving service for students' valuables.

Storage

Some of the residential facilities have limited storage space which may be used by students if approved by the Resident Director. Students are responsible for removal of stored possessions at the end of the school year. Anything left behind is subject to disposal, and a fine may be assessed to the student's account. There is <u>limited storage</u> space available over the summer for possessions of international students and students who live <u>more than 400</u> <u>miles</u> from the campus. Furniture and carpeting may not be stored. The university holds no responsibility for the possessions of any student while stored in the residential facility.

Sunbathing

Sunbathing is not permitted on the campus. Modest attire is expected of all students when not in the privacy of the residential facilities.

Water Balloons/Squirt Guns

Water balloons, squirt guns, water fights, and snowball fights are not permitted in the residential facilities.

Windows and Screens

Students are not permitted to remove window screens at any time. Entering or exiting a building through a window is prohibited and will result in a fine of \$25 and/or disciplinary action except in the case of an emergency.
